PPO fee increase effective August 1st!

A PPO fee increase went into effect on August 1st, 2023. If you have not received a copy of the fee schedule yet, please click the link below. Important update for PPO providers: Upon review, DDOR has made an adjustment to the FMX fee (D0210). Please see the attached fee schedule which contains the new fee and ensure your practice management software is updated accordingly. We understand the original FMX fee may have caused some x-rays to be bundled in error. This was not DDOR's intention. If you have any claims affected, please resubmit a corrected claim with a notation in the remark's sections stating, "Not a duplicate claim, contracted fees have been updated."

Oregon Credentialing and Recredentialing Application

Established by [House Bill 2144](#) in 1999, the Advisory Committee on Physician Credentialing Information (ACPCI) develops the uniform applications used by hospitals and health plans to credential and recredential practitioners within the State of Oregon. As of April 2023, an updated version of this application has been mandated for use by credentialing entities. Previous versions of the Oregon Practitioner Credentialing Application (OPCA), and Recredentialing Application (OPRA) will no longer be accepted or processed.

You can access the updated forms at deltadentalor.com. DDOR will continue to send your normal re-credentialing application reminders. Please also note that re-credentialing must be completed by the 1st of the month in which you are due. This will be noted on the mailing sent to your office. Please ensure that you respond promptly to avoid any lapse in credentialing.
