Does the Center for Medicare and Medicaid Services (CMS) require me to be directly opted-in with Medicare (CMS) when contracting with Delta Dental of Oregon as an in-network Medicare Advantage Provider?

- No! Joining our network does not result in changes to your direct CMS status. You are also not required to directly opt-in or opt-out with CMS to join our network.

When was the last time you've verified your information on the National Plan & Provider Enumeration System (NPPES)?

Once an NPI is assigned it's not uncommon for providers to forget to maintain their NPPES information. NPPES is one of many sites that insurance carriers use to validate provider data. As your career progresses and life brings new opportunities, it's important to ensure the NPPES site has accurate information about you.

Below are some common reasons to check and update your information:

1. Recent name change
2. Moved to a new practice location
3. Practicing in a new or additional state
4. Graduated from a specialty program

If any of the above scenarios have occurred, we highly recommend checking and updating your NPPES profile.
