

PreViser Update

Say farewell to Oral Health Information Suite (OHIS) version 4 and hello to PreViser's newest Clinical Suite version 5.



A note from PreViser detailing changes from the Oral Health Clinical Suite version 4 to their newer Clinical Suite version 5.

Over the last year, you may have heard about our new and improved PreViser Clinical Suite 5. This latest version is the future of Oral Health Risk Assessments. Clinicians spoke and we listened, adding many new features and enhancements like:

- **Mobile compatibility:** With a new user interface that is easier to use and works well on tablets and other mobile devices.
- Improved Patient Risk Analysis Report: The PreViser Risk Assessment scorecard is redesigned and easier to understand. It can be printed or emailed directly to your patients in either English or Spanish.
- **Support for the latest browsers:** PreViser works best with Google Chrome, Microsoft Edge, and IOS Safari. Clinical Suite 5 is not compatible with Microsoft Internet Explorer. If you are using this browser, we recommend updating to a new browser.

What do you need to do?

Nothing! When Oral Health Information Suite 4 is phased out on **March 31st**, your bookmarks will automatically route you to the new version 5. Your username/password and PINs will all work the

same as they did before. We recommend you start using Clinical Suite 5 today so you can access the new features right away. That way, you also get used to the new look and feel even before the switch. To access Suite 5, login to OHIS version 4 and click **Login to Clinical Suite Now**
